During each new session of the South Dakota Legislature, the South Dakota Arts Council (SDAC) presents our annual report, which includes a complete listing of grants, initiatives, and special projects awarded to South Dakota organizations, schools, and artists during each fiscal year. Due to the pandemic sweeping the nation in early 2020, the National Endowment for the Arts (NEA) – the source of our agency’s federal funds – automatically extended the period for our State Partnership Agreement by two years to allow flexibility as we responded to the needs of the arts sector and our partner communities. This was followed by the automatic extension of our subsequent State Partnership Agreement with the NEA in 2021 for the same reasons.

SDAC was able to extend accommodations to many of its grantees to allow them more time to complete projects that were delayed or events that had to be rescheduled due to the pandemic. Therefore, many of our grants awarded in State Fiscal Years 2020 and 2021 have been extended, preventing us from compiling all the data needed for our traditional annual report. However, all SDAC grant data from FY20 and FY21 are forthcoming. We will offer an extended edition of our annual report, including both FY20 and FY21 data, during next year’s legislative session.

The extensions of our last two State Partnership Agreements with the NEA not only afforded SDAC the ability to make accommodations for grantees during the pandemic, but also gave us the time needed to accept and disburse federal pandemic-relief funds from the NEA to benefit the statewide arts sector, through the Coronavirus Aid, Relief, and Economic Security Act (CARES) in FY20 (\$422,800) and the American Rescue Plan Act (ARPA) in FY21 (\$751,500). With generous support from the S.D. Legislature in 2021, our agency received an additional \$250,000 to provide more relief to South Dakota’s artists and arts organizations, and these funds have been obligated through grants and are currently being distributed. A detailed report on these funds was delivered to the S.D. Joint Committee on Appropriations in late 2021, and because they were awarded in FY22, they will appear in SDAC’s FY22 annual report in the future. The full list of pandemic-relief grants awarded by SDAC in FY21 will appear in this report as will a small number of FY20 emergency assistance grants awarded by SDAC after submission of last year’s impact report.

The South Dakota Arts Council recognizes this moment as an opportunity for the state’s arts sector not just to re-establish old ways of operating, but to rebuild in a way that works better for all arts organizations and artists. Our agency seeks to support South Dakota arts organizations and artists recover, re-establish, and rebuild from the pandemic. And as it has for 56 years, the South Dakota Arts Council continues to provide programs and nurture partnerships that have a beneficial impact on our state’s quality of life, cultural tourism, and economic development.

While this document is not a complete accounting of the South Dakota Arts Council’s work in FY21, we have accomplished much in the last year worth reporting. This report helps illustrate our agency’s effort to respond to the pandemic while continuing to seek innovative ways to support the statewide arts community, the backbone of South Dakota’s creative economy.

ARTIST WADE PATTON is an enrolled member of the Oglala Lakota Tribe and grew up in the Pine Ridge Indian Reservation surrounded by a rich culture of music and art. His current body of work shown in *Roaming* shows the influence of the place where he is from and the stories of his heritage, which he feels is important for those who aren't familiar with Lakota legends and keeping the traditions alive.

After obtaining a BA in art from Black Hills State University and having his first solo exhibit at the Sioux Indian Museum in Rapid City, Patton decided to move away to explore other artistic endeavors. When he returned to South Dakota, he dove straight into a more thriving art area and a diverse contemporary Native art scene that was not present when he left.

Patton has been reacquainting himself more-so with the land and his ancestry which is now more prevalent in his current artwork. Patton says his artwork is more mature and more respectful of his people and stories and the land where he is from. Through contemporary storytelling in design with his most recent works, he hopes to create understanding and conversation in explaining the meaning of the piece.

55 YEARS OF SERVICE

Established in 1966 and funded by the State Legislature and the National Endowment for the Arts, the South Dakota Arts Council is a state agency serving South Dakotans and their communities through the arts. The Council is the advisory board to the SDAC staff within the Department of Tourism. Council members are appointed by the Governor.

The South Dakota Arts Council was created to unify and coordinate the development of the arts across the state through public service, arts education programs, access and inclusion, cultural tourism, grants and services, and to act as the steward of the state's federal appropriation from the National Endowment for the Arts.

PURPOSE

Recognizing the importance of creativity in the lives of all South Dakotans, the Council makes quality arts accessible throughout the state by providing encouragement, grants, services and information to artists, arts organizations, schools and the public. The Council strives to ensure access to the arts and educational arts opportunities as part of lifelong learning in South Dakota.

VISION



* Amounts presented here reflect the South Dakota Arts Council's financial program overview as it was heading into State Fiscal Year 2021. Due to the pandemic, the National Endowment for the Arts extended State Partnership Agreements to allow for accommodations, so SDAC's FY21 is currently ongoing, and FY21 adjusted/actual grant amounts will be reported after being completed and finalized.

**Emergency pandemic-relief funds awarded to SDAC by the S.D. Legislature in spring of 2021 (\$250,000) to support the statewide arts sector were distributed in grant awards in FY22 and will therefore appear in the SDAC FY22 Annual Report to the Legislature next year.

The Fallout Creative Community in Aberdeen provided collaborative mural projects for creative expression and collaboration during the pandemic. Outline drawings were created by more than 100 people and distributed with painting kits to more than 15 established local artists. The painted pieces were then reassembled and touched up to form large murals as shown in the photo.

PANDEMIC RELIEF FOR SOUTH DAKOTA'S ARTS SECTOR

Like the previous year, State Fiscal Year 2021 presented challenges to South Dakota's arts sector in the wake of the Coronavirus pandemic. Many artists struggled to earn a living while arts organizations battled uncertainty regarding whether they should reopen their doors to programming and the public, a decision that sometimes had to be made from week to week depending on data related to spread of the COVID-19 virus. Such decisions were especially difficult prior to vaccines becoming widely available in the spring of 2021, but even after that, outbreaks in various community settings, e.g., schools, health-care facilities, etc., led to frequent cancellation or rescheduling of arts events and related job opportunities for artists.

The National Endowment for the Arts (NEA) contributed to relief for South Dakota's arts sector in April 2020 by granting the South Dakota Arts Council \$422,800 via the CARES Act to offer emergency assistance grants to eligible arts organizations without any catch-matching requirements attached (the vast majority were detailed in last year's annual report). A year later the South Dakota Legislature generously contributed to recovery efforts for the arts sector by awarding the Arts Council \$250,000 to be distributed for pandemic relief; a full report has already been submitted to the Joint Appropriations Committee, but these relief grants will also be detailed in next year's annual report as they were awarded in FY22. Then in June 2021 the NEA made official its commitment to providing another round of pandemic-relief funds for state arts agencies, this time via the American Rescue Plan Act. The South Dakota Arts Council's SFY21 State Partnership Agreement with the NEA (FFY20) was amended to be increased by \$751,500 for additional emergency assistance to the state's arts sector, and the grants awarded from these funds in the fall of 2021, as well as a small number of emergency assistance grants from CARES funds not previously reported, are detailed in the following pages.

GOVERNOR'S 2021-2022 STUDENT ART COMPETITION

**ARTS EDUCATION IN SOUTH DAKOTA STIMULATES CREATIVITY,
COMMUNICATION, AND LIFELONG LEARNING**



The Governor's Student Art Competition was created in 2020 in recognition of the importance of arts education and its positive impact on student learning. The program – a collaboration between the South Dakota Arts Council and Gov. Kristi Noem – came back strong for a second year in 2021 with more than 200 students from across the state submitting their work for consideration. The competition is announced the second week in September each year during National Arts in Education Week.

Winning artwork is currently on display in an exhibition on the first floor of the Capitol until September. A dozen pieces of art were selected by an esteemed panel of judges for the 2021-2022 program year, including three from each of the following categories: grades K-2, 3-5, 6-8, and 9-12. To uplift these young and talented student artists, the South Dakota Arts Council will again offer to purchase these winning pieces for display in state buildings in Pierre.

FY21 ART FOR STATE BUILDINGS

The Department of Tourism and staff and board members of the South Dakota Arts Council were pleased to see a return of the agency’s Art for State Buildings program in State Fiscal Year 2021 after having to shutter it in FY20 due to concerns about state revenue shortfalls during the early stages of the Coronavirus pandemic. Many South Dakota artists submitted proposals in FY20, and they were all invited to again submit their artwork for consideration in a fully funded FY21.

The selection committee for the Art for State Buildings program met April 8, 2021, to determine purchases for the state’s public art collection, on display in the Capitol and other state buildings in the Capitol complex in Pierre. The committee reviewed and scored proposals from 31 artists and agreed to purchase 13 new artworks from 12 artists. The \$20,100 budget supported the acquisition, shipping, and installation of those artworks shown here and also on page 3.


